## Administrative Guidelines for The Madame Jian Ye Yu Feng Scholarship

2016.10.28 Passed at the 1<sup>st</sup> General Meeting of the College of International Studies and Social Sciences  
Amendment passed at the NTNU Scholarship Management Committee meeting of  
Academic Year 2016-2017

- Article 1      Rationale: This scholarship was established by Professor Ying-Ying Jian of the Department of Chinese as a Second Language, National Taiwan Normal University (NTNU), and her family in loving memory of her late mother, lay Buddhist devotee Mrs. Jian Ye Yu Feng. With this scholarship, Prof. Jian wishes to express her gratitude to her mother and repay her nurturing spirit and hopes to encourage talented students to pursue academic excellence and accomplishments in their field of study.
- Article 2      Scholarship slots and eligibility: The applicants must be master's students in the College of International Studies and Social Sciences (hereinafter referred to as "the College") in their second year of study or above. Two scholarship recipients shall be selected from among the applicants, with one slot reserved for a graduate student in the master's degree program of the Department of Chinese as a Second Language.
- Article 3      Scholarship amount: An annual scholarship award of NT\$15,000 shall be awarded to each recipient.
- Article 4      Application requirements and criteria:
- I.      Applicants must not have received another NTNU scholarship in the semester of their application.
  - II.     Applicants must have maintained an average grade of 80% (or GPA of 3.38) or higher in the preceding academic year.
  - III.    Applicants who have carried out research in any of the following fields of study will be given preference: women's studies, gender studies, intercultural studies, the arts, Chinese-language literature, Chinese-language film studies, studies of marginalized and disadvantaged groups
- Article 5      Application deadline and process:
- I.      Application deadline: Applications must be submitted by the end of March each year. The scholarship shall be awarded by the end of May each year.
  - II.     Application process: Applicants shall submit their application with supporting documents demonstrating their eligibility and their academic transcript for the preceding academic year to their associated department/institute. Each department/institute of the College shall then select one student for nomination to the College Office for the secondary review. Graduate students shall submit their published paper(s) or the title/proposal of their thesis in any of the fields of study stipulated above.

III. Departments and institutes shall stipulate their own regulations governing the selection of scholarship candidates. Applications shall be submitted in accordance with the College's scholarship announcement in the given year.

Article 6 Review committee and procedures: After the scholarship applications for the year have been reviewed by the College's Administrative Meeting, the list of recipients for that year shall be sent to NTNU before the end of April for the disbursement of the scholarship.

Article 7 Custody and use of the scholarship fund:

- I. The NTNU Scholarship Management Committee is charged with custody of the scholarship fund. The scholarship reward money shall be disbursed from the principal and accrued interest of the fund.
- II. The scholarship amount and number of available slots may be adjusted as needed by the General Meeting of the College of International Studies and Social Sciences.

Article 8 These Regulations shall take effect after being passed at the General Meeting of the College of International Studies and Social Sciences, submitted to the NTNU Scholarship Management Committee for verification, and approved by the President. The same applies to all subsequent amendments.
